

1 | INTRODUCTION

NAGA is running a 'Friends & Family Programme (the "Programme") and invites all its new and existing clients to register. By registering and participating in the Programme, you agree to be bound by the Terms and Conditions (the "Terms") set out below.

2 | RECEIVE A 25 USD REWARD

Eligibility:

1. To be eligible to participate in the Programme, you (the "Referrer") must have:
 - (a) a live account with NAGA. All accounts are opened subject to our standard account opening compliance criteria, and as such not all applicants will be successful in their application;
 - (b) an existing business or personal relationship with the person you would like to refer; and
 - (c) agree and comply with these Terms.
2. The person you would like to refer (the "Referral") must:
 - (a) open a live account with NAGA subject to our standard account opening compliance criteria;
 - (b) be a new client to NAGA, not having previously held an account with us;
 - (c) fund the account with a minimum deposit of 200 USD (or currency equivalent); and
 - (d) make one trade of any product within 6 months of being referred.

The Reward:

1. Provided that you and the Referral meet the Eligibility criteria set out above, NAGA shall credit your live account with the withdrawable amount of 25 USD (or equivalent currency) within 10 business days.

2. The person you would like to refer (the "Referral") must:

- (e) open a NAGA Wallet subject to our standard account opening compliance criteria;
- (f) purchase at least 50 NAGA COIN;

The Reward:

1. Provided that you and the Referral meet the Eligibility criteria set out above, NAGA shall credit your NAGA Wallet with NAGA COIN equivalent to 5% of the amount purchased by the Referral within 10 business days.
